Minutes of Annual General Meeting Shree Geeta Bhawan

1. Attendees:

38 members attended (list attached). The quorum was attained and the meeting was held under the patronage and chairmanship of Mr R K Sethi.

2. Welcome:

The President Dr A N Verma (ANV) welcomed the members

3. Minutes of the last meeting held on 31/10/2010 (previously circulated) were tabled by the Secretary Dr Ojha (HO) and were unanimously approved by all present as a correct record.

4. Matters Arising:

- Mr Ashok Bharadwaj raised an issue about the confirmation of last election held on 31/10/2010. Mr Chandan the secretary of the time confirmed that he had received the confirmation of the results and had replied to the queries raised therein. Mr Bharadwaj requested to see the letter and HO confirmed to share the contents with Mr Bharadwaj.

HO read the highlights of the report (which he had previously circulated) and which was unanimously approved.

6. Financial Report:

HO read the highlights of the financial report (prepared by Mr Tony Chawla) and previously circulated. The members appreciated the hard work in preparing the accounts and accepted the report.

Mr Bhalla enquired about the breakdown of expense for the Shikhara Project which had far exceeded the original projection
