# Minutes – Annual General Meeting – 9th October 2022

#### 1. Welcome

## 8. Any Other Business

- MM reported to the members that the case filed against SGB by Factory Building Services on the instigation of some former committee members had been defeated with the grace of Shree Lord Krishna.
- 2) Attempts were made to remove Murria Solicitors for defending SGB which was successfully resisted by Murria Solicitors. The solicitors acting for the builders disclosed 2 tenders with different prices for the same work. Murria Solicitors waived their entire legal fee. We have been considering bringing a claim against those who instigated the builder to sue SGB.
- 3) Investigation by the Charity Commission was satisfactorily concluded. Some members tried to mislead the Charity Commission by providing false information with the sole aim of harming the interest of SGB and cancellation of its charity status. Murria Solicitors acted for SGB which took the professional time of several hours and included the preparation of a 40 pages report with an additional 500 pages of supporting documents. This investigation was a massive distraction, but the entire committee remained united with the grace of Shree Lord Krishna. Murria Solicitors had written off several thousands of pounds of legal fees.
- 4) Several members at the SGB praised the work and the commitment of the committee.
- 5) Mr Rajinder Sehdev suggested that that the surviving spouse of the deceased member ought to be given membership of the SGB free of charge. MM stated that the new committee will consider his request.
- 6) Mr Ram Gogna suggested that SGB ought to publish a regular newsletter. MM stated that the new committee will consider his request.
- 7) Dr Arun Sinha praised the sheer dedication, hard work and commitment of MM to SGB'S work carried out with honesty and integrity.
- 8) Mr RK Sethi commented that this AGM has been one of the best AGMs he attended.
- 9) Seshwar Sehra wanted the youth to be committee members, MM stated that to be a committee member, a person must be mature, and they also need to prove that they are committed & prepared to do selfless seva without seeking any position. MM told him that the committee is introducing youth into the committee, however, the youth are always welcome to serve as sevadars.
