Withdrawal of nomination forms can be accepted until  $\frac{12.00noon}{200m}$  6th September  $\frac{2014}{200m}$ .

We will be happy to send a nomination by proxy form provided you make a request to the Electoral Committee of SGB at least 14 days before the Election.
